1. Call to Order and Roll Call:

2. Acceptance of Agenda:

- Agenda Approval: CM Baltzell made a motion to amend the Agenda to add an Executive Session, seconded by CM Fleck. Motion passed with a roll call vote 7-0 Aye. CM Buxton made a motion to accept the Agenda, seconded by CM Clausen. Motion passed with a roll call vote 7-0 Aye.

3. Corrections and acceptance of the Regular Council Meeting Minutes:

7. Old Business (2nd Reading):

- a. **41-25-O:** An Ordinance to make appropriations for expenses and other expenditures of the City of Celina, State of Ohio, during the calendar year ending December 31, 2026, and to declare an emergency.
Discussion:

- CM Clausen stated the 2026 budget has been discussed in Personnel & Finance Committee meetings. Minor modification will be made before the final third reading. Documents are available to the public to review.
 - Outcome: CM Baltzell made a motion to pass to third reading, seconded by CM Gray. Motion passed with a roll call vote 7-0 Aye.

- b. **42-25-O:** An Ordinance authorizing the Safety-Service Director to advertise for bids and to enter into contracts for City Projects and Capital Equipment for fiscal year 2026.

Discussion:

- Outcome: CM Clausen made a motion to amend to remove "West Side" under Administration Building- West Side Brick Repair & Tuck Pointing, seconded by CM Fleck. Motion passed with a

roll call vote 7-0 Aye. CM Fleck made a motion to pass to third reading, seconded by CM Buxton. Motion passed with a roll call vote 7-0 Aye.

c. **43-25-O:** An Ordinance authorizing the Safety Service Director to advertise for bids and to enter into contracts for certain materials, services, supplies and equipment needed during 2026, and to declare an emergency. (Amended 11/10/2025)

Discussion:

- Outcome: CM Baltzell made a motion to pass to third reading, seconded by CM Buxton. Motion passed with a roll call vote 7-0 Aye.

a. **40-25-O:** An Ordinance establishing the annual salary of the Clerk of Council.


